# FHA Reps Meet With Commissioner of Public Lands

On Thursday, August 12, 1993, representatives of the Floating Homes Association Executive Board met with Jennifer Belcher, Commissioner of Public Lands, to discuss the on-going problems associated with State DNR leases of aquatic lands. Those individuals making the trek to Olympia were Marty Alexander, Sheri Gotay, Bill Keasler, Frank Koterba, and Phil Webber.

Our FHA reps explained that the main problem is in the lease language itself. The standard DNR lease is commercial in nature; therefore, the language is not appropriate to residential use. Some of the provisions of the standard lease

constitute an unreasonable risk to floating home owners.

DNR has expressed willingness to negotiate lease language with individual lessees, but it is FHA's intention to resolve the language concerns and have a standard lease for all floating home moorages.

Other issues, like equity in lease rates, length of lease, the specific area to be leased, were also discussed. Ms. Belcher stated that a committee of lessees is being established to review the entire aquatic lands lease process, and that the review should be completed in two to three months. Because floating home owners represent a unique use of aquatic lands

and also take on a substantial and unique risk, FHA requested representation on the review committee. FHA requested that a moratorium be placed on signing of leases until this review process has been completed. Ms. Belcher said that a moratorium could not be granted, nor could she promise FHA representation on the advisory committee, but asked that our concerns be put in writing for consideration in the review process.

After the meeting, a letter was sent to Ms. Belcher reiterating FHA's concerns, along with a document written by FHA attorney, Peter Eglick, spelling out the specific problems with the lease language. A moratorium was again requested on signing of leases, and an interim solution was suggested in that current (or, in some cases, expired) leases be extended for a certain amount of time while the review and negotiation process is underway. Lessees could continue to make payments on their leases and be in compliance with State law. A copy of the letter is available to read in the Floating Homes office.

Letters were also written to
Senator Brad Owen, Chair of the
Senate Natural Resources Committee,
Senator Janice Neimi, Representative
Cal Anderson, and Representative Pat
Thibaudeau, asking for their support in
this matter. Individual letters from
FHA members to these legislators are
encouraged to help in resolving these
issues as quickly as possible. Please
copy the FHA office with any letters
you write.

Letters have also been sent out to floating home moorage owners whose leases have either expired or will expire in the next several months explaining the procedure for renewing the lease. Even though FHA is in the process of negotiating changes to the lease document itself, moorage owners should begin taking the necessary steps required for renewing.

Currently, the Floating Homes Association is working on a legislative agenda to revise State law regarding the method of determining lease rates, length of leases, as well as other issues of concern to floating home owners.

Ms. Belcher offered to speak to the entire Floating Homes Association membership and we plan to take her up on that offer. We are trying to schedule her to speak at the Annual Meeting next April.



# "Floating Kitchens: Cooking With Seattle's Houseboaters"

The second edition of the "Houseboat Cookbook" is definitely on the front burner and should be out of the oven in time for holiday giving. Marty Alexander is the editor-in-chief. Recipes have come in from all corners of the floating community. This is home-cooking at its best and its funniest. Lots of anecdotes; even a wine column (with an historical perspective) by Tom Stockley; and whimsical illustrations by Peg Boley.



### WHY STORM DRAIN STENCILS?

Why storm drain stencils? Because poisons are damaging our water quality. Every year, people pour hazardous chemicals, pesticides, paints, antifreeze and used motor oil down storm drains. The Seattle Aquarium estimates that more than two million gallons of used motor oil ends up in Puget Sound each year. That's enough to fill a medium-sized tanker.

Some people believe that the storm drain will carry the waste to sewage treatment for cleanup. Not true! (Even if it did, chemical wastes would not belong there.) In fact, storm drains simply carry rainwater into the nearest stream, lake or Puget Sound—directly into fish habitats or sometimes drinking water.

Some Washington communities draw drinking water from surface waters, such as large lakes. Toxic chemicals don't belong there. As to maritime life, even small amounts of toxic chemicals—like antifreeze, pesticides and household cleaners—can weaken fish and make them susceptible to fatal diseases.

One pint of oil can cause a slick about the size of two football fields on calm water. The surface of the water is a vital biological habitat and serves as a nursery for developing eggs and larvae of fish and shellfish. It doesn't take much oil to smother or poison these surface organisms.

What can you do? Apply the stencil next to the storm drain grates in your community. The next time someone gets ready to dump waste down the drain, they'll get the message. ## **Shelby Street End**

"Shelby Street End" is the official name of this area on Portage Bay. The postage stamp-sized park at the foot of Shelby has no name but it is where the City of Seattle Engineering Department is working on a CSO (combined sewer overflow) project. It means that they will tear up parts of Shelby, take out some trees, cause parking chaos and make a big mess for only 44 days. (They promised!). Most importantly, when they're done, the results will be a new replanted tree-lined street and cleaner water in Portage Bay! Definitely, a worthwhile endeavor.

But, in 1906, the foot of "Shelby Street End" was not a park but the home of "Indian John" (also known as "Old John", "Chodops John" and "Shiadups John"), and his wife Madeline. According to the book, UNSINKABLE HOUSE-BOATS, he and his wife were well known on the Lake and their home was the last traditional Native American settlement on Lake Union/Portage Bay. In 1906, "Indian John" held a potlatch to honor his wife's passing. Over 100 people attended and each one received one dollar and some food.

I suggested to Pam Miller at the Engineering Department that since the City was willing to replant trees as a result of the CSO project, they should also place a commemorative plaque to honor the history of that site. She thought it was a great idea. So did the Flaoting Homes Association, the Roanoke Community Council and Walter Pachico of the Muckleshoot Tribe. In short, plans are underway to relandscape the park in a Native American theme creating a place where one can have a few quiet moments for reflection. The Muckleshoots will perform a private and public Native American ceremony and a commemorative plaque will be placed. So far, the FHA, Seattle Engineering Dept., 1% for Arts and the Muckleshoots will provide funding. The ceremony is tentatively planned for next spring.




The cycle of Seasons here on Lake Union has brought us to another Autumn. The annuals are doing their last bit of flowering and seed-setting before the temperatures drop.

As night-time temperatures begin to go below 45 degrees, many plants will begin to go dormant. The annuals will start to die and geraniums will not set any further flower buds.

This cycle for perennials and shrubs is called "hardening off." The plants are preparing for winter and cold weather,

Best of all, the pesky aphids will start to disappear and also the spider mites; this has been one of the worst years I have seen for mites. It has probably been caused by the long wet spring and summer. The leaves of marigolds, petunias and other annuals will look dusty and stippled from the mite webs and the injury from their feeding. To reduce overwintering of mites and diseases, be sure to do a very thorough clean-up of old leaves. Even washing the pots off will help. You can spray with an insecticidal soap to try to kill them but at this time it really is too late.

Now that your Clean Green recycle containers are full and your pots are empty, it's time for pansies and chrysanthemums. Be sure to purchase the mums mostly in bud so you get a longer season out of them. You can get more flower if you cut off old flowers but without a very long Indian Summer (and some plant food), this usually does not result in much flower or production.

Pansies are the best and last longer but only if you remove old flowers weekly without fail. They will respond to a little 20-20-20 or Rapid Grow in the water occasionally through late October. Don't water pansies, left-over geraniums or any other holdouts in the evening as the added wet and damp along with nighttime humidity will cause mildew and other disease problems.


# Its 25th Anniversary On Portage Bay


#### SPLICE THE MAIN BRACE
